Dennis "Denny" Lee Weber Sr., age 77, of Alta, Iowa passed away on Friday, May 28, 2021 at his home in Alta.

A loving husband, father, grandfather, and great-grandfather, Denny always put his family first. Born in Fort Dodge, Iowa on May 28, 1944, Denny was the son of Eileen (Messerly) and Lorence Welter; Allen and Helen Weber. He was baptized into the Christian faith at the Assembly of God Church in Fort Dodge.

Denny attended school in Barnum, IA. He continued his education at North Central Bible College in Minneapolis, MN from 1962 until November 1964 when he enlisted in the United States Army. He served with the 14th Armored Cavalry in Bad Hersfeld, Germany, then in Washington, D.C. with the Department of Intelligence. On January 8, 1966, Denny

was united in marriage to Jane Lightfoot at the Assembly of God Church in Fort Dodge. Jane joined him in Germany for the remainder of his tour. Their union was blessed with two sons; DJ and Mike. During his time with the Army, Denny quickly moved through the ranks and was honorably discharged as a Staff Sergeant in 1968. Denny and Jane made wonderful friends during his enlistment and kept in touch by traveling throughout the US for Army reunions.

Denny and Jane lived in Manson, IA then moved to Alta, IA in 1976 where he began his career as a high voltage electrical equipment salesman. Denny took pride in his work and fostered many friendships throughout his career - often quoting "If you enjoy what you do, you will never work a day in your life." He retired from "work" in 2014.

Denny served his community with the same enthusiasm he gave to work. Denny served 26 years on the Alta football chain gang crew and the crew was selected for two of the state championship games at the dome. He also served on the Alta Utility Board of Trustees (24 yrs.), the BV County Republican Central Community (15 yrs.), the Alta Golf Board (9 yrs.), BV County Ag. Society (5 yrs.), and the Alta City Council (4 yrs.). In his leisure time, Denny enjoyed playing golf or a game of cards with friends, collecting coins, and he relished time spent at family celebrations.

Denny's life was a life well spent, and we thank our Lord for the time we were given with him. Denny was preceded in death by his parents, Eileen and Lorence Welter; Allen and Helen Weber; father and mother in-law, Lowell and Dorothy Lightfoot; sisters-in-law: Debbie Weber, Betty Poling, Luetta Lightfoot, and Holly Lightfoot; brothers-in-law: Jimmie Lightfoot, Ted Lightfoot, and James Poling.

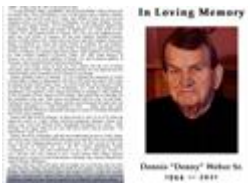
